MINUTES for the Mission Directorate Meeting of the National AYUSH Mission (NAM) for the year 2022-23

- 1. The Mission Directorate Meeting (Through Video Conference) under the National AYUSH Mission (NAM) for the year 2022-23 was held on dated 25th Nov, 2022 under the Chairmanship of Vaidya Rajesh Kotecha, Secretary, Ministry of AYUSH to consider the State Annual Action Plan (SAAP) of State Government of Maharashtra, **Ladakh**, Bihar. Punjab, Jharkhand, Odisha, Meghalaya, Uttarakhand, Andaman and Nicobar Islands, Nagaland and Gujarat. List of the participants is enclosed at **Annexure-I**.
- 2. At the outset, Joint Secretary, Ministry of Ayush welcomed the representatives of State/UT Governments to the Mission Directorate meeting and briefed that the State Annual Action Plan (SAAP) for the States of Maharashtra, **Ladakh**, Bihar. Punjab, Jharkhand, Odisha, Meghalaya, Uttarakhand, Andaman and Nicobar Islands, Nagaland and Gujarat have already been appraised during the Appraisal Committee meeting and detailed observations were communicated to the States.
- 3. Further, it was also informed to the Mission Directorate that during the Appraisal Meetings, a detailed review of progress of Expenditure and PFMS Implementation has been carried out. It was suggested that State Governments has to expedite the progress of expenditure and to ensure submission of UCs of at least 75% of the previous released grants-in-aid. Further, it is also required to fulfill the compliance of different conditionalities including PFMS implementation which are the necessary criteria for release of grant as per the direction issued by the Department of Expenditure vide no.1(13)/PFMS/ 2020 dated 23.03.2022 and Corrigendum dated 21.06.2022.
- 4. After that a brief presentation made by Deputy Adviser (Ayu) for each State highlighting the following aspects of
- i. Year-wise Progress of expenditure and status of UCs submitted under NAM
- ii. Status of AYUSH HWCs
- iii. Status of submitted SAAP during 2022-23.
- iv. Status of implementation of PFMS.

The State-wise detailed observation are enclosed in ANNEXURE-II.

Ladakh

Mission Directorate reviewed the Expenditure & Utilization Certificates status of the UT Govt. against the previous years grants-in-aid released to the State under the NAM scheme, Status of PFMS implementation, Status of Ayush HWCs, Status of submitted State Annual Action Plan and made the following observations and recommendations:

Expenditure & Utilization Certificates

- Status of Expenditure: Under NAM, an amount of Rs. 187.450 Lakhs as Centre Share has been approved during the year 2021-22. UT Govt. has reported an expenditure of Rs. 25.15 lakhs (13.40 %) against central share to Ministry. Further, it was suggested that UT Govt. has to expedite process of utilization of released grant-in-aid of previous year upto 75% and submit the Utilization Certificate for the same at the earliest and also explore the possibility to surrender the amount which may not be utilized to CFI of GoI.
- Status of Utilization Certificates: UT has not submitted UCs against the UC due. In the meeting, it was suggested that UT has to ensure effective utilization of release grant in time bound manner and submission of the UCs for the same to the Ministry. It was also suggested in the meeting that UT Govt. has to submit the Utilization Certificates along with relevant supporting documents for utilized amount. Accordingly, UT Government has agreed that they will expedite the process of utilization of released grant-in-aid and submit Utilization Certificates & relevant supporting documents for the same at the earliest. Further, during the meeting it was suggested that the UT Govt. has to explore the possibility for returning the unspent amount lying with the State Govt. within 15 days.

Status of PFMS

Implementation of PFMS is not applicable.

AYUSH Health & Wellness Centres (Ayush HWCs):-

It was noticed that an amount of **Rs. 162.324 lakhs** is lying unspent in the State AYUSH Society. Accordingly, the UT Govt. was requested to highlight the strategy regarding expenditure of the unspent amount. In this regard it was clarified by the UT Government that an amount of Rs. 55.104 lakhs were released for Ayush HWCs activity and same could not be utilized because approved 14 units of Sub-centres has already been converted as HWCs by Health Department and accordingly release amount of Ayush HWCs activity will be surrendered to the GoI. In the meeting, it was suggested that UT Govt. may explore the possibility for submission of proposal of Ayush HWCs for new units and also intimate to the Health Department that approved 14 units

could not be upgraded as Ayush HWCs because same has already been upgraded as HWCs by Health Department.

Status of State Annual Action Plan for the year 2022-23

The UT Government has submitted the State Annual Action Plan (SAAP) for an amount of Rs. 768.92 lakhs against the communicated resource pool. Rs. 594.50 lakhs. Accordingly, Mission Directorate decided to consider State Annual Action Plan for approval as appraised by the appraisal committee subject to condition that State Government has to fulfill conditions of Department of Expenditure issued guidelines vide no. vide no.1(13)/PFMS/ 2020 dated 23.03.2022 and Corrigendum dated 21.06.2022, regarding procedure for release of funds under the Centrally Sponsored Schemes (CSS) and monitoring utilization of the funds.
